Terms & Conditions:

1. The bidders are advised to submit the tender well in advance to avoid any unforeseen difficulties in the **Limited tender form** as per Annexure - A.
2. The bidder should render support for minimum period of 6 months.
3. The firms are required to take the responsibility to provide update of any development on the method for at least 5 years, in the event of any of the becoming obsolete.

4. Rates/ Prices:

- (i) The rates should be quoted in Indian Rupees only in words as well as in figures.
 - (ii) Rates should be valid for at least one year. Rates valid for a shorter period shall be rejected as non-responsive.
 - (iii) The rates quoted should be for New Delhi, inclusive of all taxes and levies.
 - (iv) If any new tax/duty is levied on subject goods, the same will be borne by the successful bidder exclusively.
 - (v) No claim for compensation or loss due to fluctuations in prices or any other reasons/causes will be entertained.
5. The supplier should hold valid GST number. Scanned copy of its registration certificate should be submitted along with quotation.
6. **Delivery Period:** Supply order will be placed as and when required. The supply shall have to be made in one installment within 30 days from the date of issue of supply order.
7. **Declaration:** The bidders must submit a certificate on their letter head that they have not been debarred for supply of the items mentioned in the tender by any government/autonomous bodies/PSUs etc.
8. A general undertaking on the letter head of the firm that all terms and condition of this Bid Document are acceptable is required to be submitted alongwith bid documents.
9. **Mode of Payment:** Payment against Bill/Invoice shall be released only after successful development of method and to the satisfaction of the CRCL. No interest will be payable for any delay. Payment will be made directly to the suppliers through RTGS/NEFT in their bank account after deduction of TDS, if any. No request for any other mode of payment will be entertained.

10. After opening of tender, a Committee will assess offer by the bidders and other acceptable T&C.

11. **Award Criteria:** The contract shall ordinarily be awarded to the lowest evaluated bidder whose bid has been found to be responsive and who is eligible and qualified to perform the contract satisfactorily as per the terms & conditions.

12. **Purchasers Rights:** CRCL reserves the right to accept/reject any or all the bids in whole or in part and annul the bidding process without assigning any reason whatsoever and is not bound to accept the lowest tender.
