

MEMORANDUM

[Rule 14 of CCS (CCA) Rules, 1965]

The undersigned proposes to hold an inquiry against **Shri Suresh Udutha, Chemical Assistant, Custom House Laboratory, Chennai**, under Rule 14 of the CCS (CCA) Rules, 1965. The substance of the imputations of misconduct or misbehaviour, in respect of which the inquiry is proposed to be held, is set out in the enclosed statement of article of charge (Annexure-I). A statement of the imputation of misconduct or misbehaviour in support of each article of charge is enclosed (Annexure-II). A list of documents by which and a list of witnesses by whom, the articles of charges are proposed to be sustained are also enclosed (Annexure-III and IV).

2. **Shri Suresh Udutha, Chemical Assistant, Custom House Laboratory, Chennai** is directed to submit within 10 (ten) days of the receipt of this Memorandum a written statement of defence and also to state whether he desires to be heard in person.

3. **Shri Suresh Udutha, Chemical Assistant, Custom House Laboratory, Chennai**, is informed that an inquiry will be held only in respect of those articles of charge as are not admitted. He should, therefore, specifically admit or deny each article of charge.

4. **Shri Suresh Udutha, Chemical Assistant, Custom House Laboratory, Chennai**, is further informed that if he does not submit his written statement of defence on or before the date specified in para 2 above, or does not appear in person before the Inquiring Authority or otherwise fails or refuses to comply with the provisions of Rule 14 of CCS (CCA) Rules, 1965, or the orders/directions issued in pursuance of the said Rules, the Inquiring Authority may hold the inquiry against him ex-parte.

5. Attention of **Shri Suresh Udutha, Chemical Assistant, Custom House Laboratory, Chennai** is invited to Rule 20 of the CCS (Conduct) Rules, 1964, under which no Government servant shall bring or attempt to bring any political or outside influence to bear upon any superior authority to further his interests in respect of matters pertaining to his service under the Government. If any representation is received on his behalf from another person in respect of any matter dealt with in these

proceedings, it will be presumed that **Shri Suresh Udutha, Chemical Assistant, Custom House Laboratory, Chennai**, is aware of such a representation and that it has been made at his instance and action will be taken against him for violation of Rule 20 of the CCS (Conduct) Rules, 1964.

STATEMENT OF ARTICLE OF CHARGE FRAMED AGAINST SHRI SURESH UDUTHA, CHEMICAL ASSISTANT, posted at CUSTOM HOUSE LABORATORY, CHENNAI.

Article-1

That Shri **Suresh Udutha**, Chemical Assistant, posted at Custom House Laboratory, Chennai, was granted 17 days Earned Leave with effect from 11.05.2022 to 27.05.2022, with suffix 28.05.2022-29.05.2022 pursuant to his application dated 10.05.2022 with permission to leave the Headquarters on 11.05.2022, and, accordingly, Shri Suresh Udutha was required to rejoin his duties on 30th May, 2022.


That Suresh Udutha, Chemical Assistant, Custom House Laboratory, Chennai, however, failed to rejoin his duties on 30th May, 2022, on completion of his 17 days' sanctioned leave.

That the Joint Director, Custom House Laboratory, Chennai had forwarded a letter vide F.No.S.Misc.37/2013-14 Lab dated 09.06.2022 by speed post, directing Shri Suresh Udutha to report for duty within three days from the receipt of said letter. The copies of the same were also endorsed to him through email (Email Id - suresh.u@gov.in) and on his whatsapp number.

That a NOTE was issued by the Joint Director, Custom House Laboratory, Chennai vide F.No.S.Misc./6/2013-14 LAB dated 16.06.2022 addressed to the Chief Accounts Officer, Accounts Section, General Commissionerate, Custom House, Chennai-I regarding his unauthorised absence with the information that no salary and allowance may be paid to him from June, 2022 till he resumes duty. A copy of NOTE was also endorsed to Shri Suresh Udutha.

That Shri Suresh Udutha, Chemical Assistant, Custom House Laboratory, Chennai, has remained unauthorisedly absent from duty since 30.05.2022, and has failed to comply with lawful orders of the superior officers.

Thus, **Shri Suresh Udutha**, Chemical Assistant, by his acts of omission and commission has shown lack of devotion to duty, conduct unbecoming of a Government servant, lack of accountability and transparency and not performing duties with the highest degree of professionalism and dedication. He has thereby violated Rule 3(1)(ii), 3(1)(iii), 3(1)(ix), 3(1)(xviii), 3(1)(xix) and 3(1)(xxi) of CCS (Conduct) Rules, 1964 and rendered himself liable for action under Rule 14 of CCS (CCA) Rules, 1965.


Shri Suresh Udutha, Chemical Assistant has joined this department on 13.03.2019 at Custom House Laboratory, Chennai vide joining order issued under F.No.S.Misc./69/LAB/2018-19 dated 15.03.2019.

2. Shri Suresh Udutha was sanctioned Earned Leave for the period from 11.05.2022 to 27.05.2022, with suffix 28.05.2022-29.05.2022. He was, therefore, required to resume duties w.e.f. 30.05.2022 (FN). However, he has failed to do so and has remained absent without prior permission of his controlling officer.

3. The Joint Director, Custom House Laboratory, Chennai had forwarded a letter to Shri Suresh Udutha vide F.No.S.Misc.37/2013-14 Lab dated 09.06.2022 by speed post, directing him to report for duty within three days from the receipt of said letter. The copies of the same were also endorsed to him through email (Email Id - suresh.u@gov.in) and on his whatsapp number.

4. Further, a NOTE was also issued by the Joint Director, Custom House Laboratory, Chennai vide F.No.S.Misc./6/2013-14 LAB dated 16.06.2022 addressed to the Chief Accounts Officer, Accounts Section, General Commissionerate, Custom House, Chennai-I regarding his unauthorised absence with the information that no salary and allowance may be paid to him from June, 2022 till resumes duty. A copy of NOTE was also endorsed to him.


5. However, Shri Suresh Udutha has failed to obey the orders of Competent Authority, and has not reported for duty till date. Thereby Shri Suresh Udutha, Chemical Assistant, Custom House Laboratory, Chennai has shown lack of devotion to duty, conduct unbecoming of a Government servant, lack of accountability and transparency and not performing duties with the highest degree of professionalism and dedication in contravention to Rule 3(1)(ii), 3(1)(iii), 3(1)(ix), 3(1)(xviii), 3(1)(xix) and 3(1)(xxi) of CCS (Conduct) Rules, 1964 and has rendered himself liable for action under Rule 14 of CCS (CCA) Rules, 1965.
